#### **TERMS OF REFERENCE**

#### **CONSULTANCY SERVICES**

#### 1. Organization background

The Eastern Africa Farmers' Federation, EAFF, (www.eaffu.org) is a regional democratic nongovernmental organization whose mission is to represent, lobby and advocate for Eastern Africa farmers interests and build their capacities. EAFF's goal is to contribute towards improved rural livelihoods and alleviate poverty in the Eastern Africa Region. The Federations role is to promote the interests of farmers on issues touching on markets, productivity, capacity, information and regional integration, under the following key pillar: a) effectiveness in policy lobbying and advocacy; **b)** institutional strengthening of farmer organizations at all levels; **c)** enhanced engagement of farers in value chains; and d) knowledge management. EAFF recognizes that strong supply chain will not only improve the incomes of the farmers but will also lead to jobs creation and food security. The core mandate and functions of EAFF are to empower smallholder farmers through lobby and advocacy for pro poor policies, facilitation of trade through promotion of regional integration and entrepreneurship, Enhancement of food security, food sovereignty and poverty alleviation; Information management through appropriate acquisition, packaging and dissemination; active engagement of women and youth in agricultural development and natural resources and biodiversity conservation. The Federation's membership consists of national farmer organizations, apex cooperative associations, apex commodity associations and apex women farmer organizations in ten countries in eastern Africa - Burundi, Democratic Republic of Congo, Djibouti, Eritrea, Ethiopia, Kenya, Rwanda, South Sudan, Tanzania and Uganda.

#### 2. Background on project

In East Africa, agroecology is increasingly seen as an approach to the food system transition. Some initiatives were born to address the current environmental challenges faced by the farmers on the ground. These initiatives include among others the project "building local economies in east Africa through agroecology" aiming at boosting local economies and improving the livelihoods of local communities in selected territories in Kenya, Uganda, Tanzania and Democratic Republic of Congo. Hubs on agroecology have also been created and

include the LUANAR AE Hub in Malawi, and the Sokoine AE Hub in Tanzania. The AE Hub based at Manor House Agricultural Centre in Kenya is focused on supporting farmers and civil society organizations that work together on agroecological research and action. Moreover, there is a DeSIRA initiative in East Africa (Ethiopia, Tanzania): LEG4DEV. Its objective is to promote scaling of legume-based agroecological intensification of smallholder maize and cassava cropping systems in SSA for water-food-energy nexus sustainability that enables food security and livelihood resilience. Despite these initiatives, a lot of efforts are yet to be made for the advancement of agroecology agenda in the region. The main constraints hindering the advancement of agroecology and farmer-led research in Eastern Africa include the top-down approach to the agricultural research, which has contributed to the poor research translation. Other hindrances include poor access to the modern technologies and innovations, perennial weather-related perils e.g. droughts, floods, etc., due to climate change, disintegration of the smallholder farming communities, hence increasing the cost of service delivery, widespread gaps in the national Agriculture hence failure to adequately articulate the needs of the smallholder farmers, inadequate extension and advisory services, inadequate access to credit facilities, poor access to the inputs and outputs markets (local and regional) and scanty value chain technical packages for the smallholder farmers.

#### 3. Background of the assignment

EAFF has received financial support from Agricord, an umbrella body for Agri-agencies globally, to strengthen agroecological policy processes in East Africa. This assignment will contribute in this process by developing a database of agroecological policies in the region. The overall objective of the assignment is to develop a database of existing agroecology policies, platforms, policy constraints and enablers to agroecology and farmer-led research on agroecology at national and regional levels. This will move ahead to strengthen the capacity of EAFF to influence agroecological policies for a better consideration of agroecology in policy documents, which in the long run will improve agricultural policies on issues related agroecology and farmer led action research on innovative agroecological approaches;

#### 4. Overall objectives

Develop a database of agricultural policies in East Africa

#### 5. Scope of work

#### Main activities and expected results/Outputs per each activity

1. Develop a database of existing agroecology policies, platforms, policy constraints and enablers to agroecology and farmer-led research on agroecology at national and regional levels

within East Africa. The consultant will develop a database of policy instruments related to agroecology policy in the region. The policy instruments include National Policies and Strategies; National Laws, Bills and Regulations. The database should cover the following:

- a. Name of the Policies, Bills and Regulations: This should include all policies, laws or regulations that have been enacted, ratified or are still in the process. This column should start by defining the sub-sector under which the policy instrument falls.
- b. Aims, Objectives and Policy Thrust/ Highlights, and role of farmer organization. The consultant should briefly describe (i) the aims and objectives of the policy, law or regulation; (ii) the main highlights e.g. the law may establish a new agency or authority; (iii) any role/ mention of farmer organizations in the policy.
- c. Current Status of the Policies, Bills, laws or Regulations: Provide an update on the status of the policy instrument. This status describes exactly at what stage the policy has reached. This should be as clear and detailed as possible.
- d. Identified gaps/ weaknesses in the agroecology policies, laws, bills, regulations: After a review of the policy document, please identify any gaps or weaknesses. This can be done during the data collection exercise, by asking the different institutions, through thorough research of the policy/laws/regulations on the primary stakeholders of the same such as farmer organizations, among others.
- e. Responsible institution: Provide the name of the government institution under which the policy, law or regulation falls. Where possible, the consultant should also provide the name/position of official contact person and his/her official contacts (e-mail and phone).
- 2. Develop a database of agroecological policy instruments in 3 East African countries, i.e. Burundi, DR. Congo and Tanzania. In this case, the consultant will develop a database of policy instruments related to agroecology in the selected countries with same format as above.

#### Approach and methodology of the assignment

To undertake this task, the Consultants may adopt the following approach:

i. Online search of secondary material: Virtually all the materials necessary for this assignment are available online. This should be the first step in the exercise. The consultant will search the websites for all relevant government organizations including the ministries, parliament library, agricultural parastatals, authorities, commodity boards,

- national farmer organizations, district offices, agricultural research institutions, among others.
- ii. Physically visiting the relevant offices in Kenya: The visits to the organizations should add value to the work. For example, where information is missing or not up-to-date.
- iii. Virtually meeting the relevant offices in Uganda and Tanzania: The virtual meetings to the organizations should add value to the work. For example, where information is missing or not up-to-date.
- iv. Physically attending parliamentary sessions in Kenya: Where possible, it is important to attend parliamentary sessions on agriculture to understand the status of specific government policies and programs on agriculture. Such meetings also include discussions on the topical issues, which would reveal information on any challenges in the sector or sub-sector.
- v. Virtually attending parliamentary sessions in Uganda and Tanzania: Where possible, it is important to attend parliamentary sessions on agriculture to understand the status of specific government policies and programs on agriculture. Such meetings also include discussions on the topical issues, which would reveal information on any challenges in the sector or sub-sector.
- vi. Collection of the documents: where possible, consultant shall to collect all the policy documents that they come across during this assignment. The documents may be collected in hard copy or electronic forms.

#### 6. **Deliverables**

The deliverables from the assignment are 2:

(a) the agroecological policy database in East Africa, which will most likely be in excel, (b) and also the consultant will develop a review document summarizing the findings.
