

#### **TERMS OF REFERENCE**

#### <u>Consulting Services to conduct a study on Family Farming Policies in support or against in line with FAO</u> voluntary guidelines in Tanzania and Kenya to include other Regional Platform 2 (strong smallholder <u>farmers</u>) countries

#### 1. Organization background

The Eastern African Farmers' Federation (EAFF) was formed in 2001 as a non-political, non-profit and democratic organization, whose role is to voice the concerns and interests of farmers of the region to enhance their social-economic status and regional cohesiveness. EAFF's establishment was championed by national farmers' organizations from Kenya, Tanzania, Uganda, Rwanda and DR Congo. Membership was subsequently extended to Rwanda, Burundi, Eritrea, Djibouti, Ethiopia and South Sudan. EAFF membership is now composed of 24 farmer organizations serving about 20 million smallholder farmers. EAFF has signed an institutional contract with the International Land Coalition to host and implement the activities of the platform jointly with the members.

#### 2. Background on project

Family farming (FF) contribute to food security globally. Both in developing and developed countries, family farming is the predominant form of agriculture in the food production sector. Family farming includes all family based agricultural activities, linked to several areas of rural development. There are more than 570million farms in the world of which over 500 million are family owned. They are responsible for at least 56% of agricultural production; in the following sectors agricultural crops and livestock, fisheries, pastoral production and aquaculture production. Family farmers work on a significant portion of the world's farmland. In Africa 62%. Farmers manage their lands to sustain remarkably high levels of productivity despite having less access to productive resources such as agricultural inputs and support. Family farming preserves traditional food products while contributing to a balanced diet and safeguarding the world's food, are the major investors in agriculture and the backbone of the rural economic structure.

#### 3. Background of the assignment

The Regional Platform 2 (RP2) themed "Strong Small-scale Farming Systems" is one such platform. RP2 aims at promoting people-centered land governance through equitable land distribution and public investment that support small scale farming among its 8 member organizations<sup>1</sup> - ROPPA, CPF, NO-VOX COTE D'IVOIRE, EAFF, PWC, PROPAC, CEPA, and MYO. The main objective of the RP2 is to consolidate ILC activities in the Sub-Saharan region and prioritize actions in line with the ILC's 10-year Strategic Framework while taking into account regional, national and local contexts. The objective and mandate of Regional Platform 2 is to support ILC Africa members in strengthening their ownership of the Coalition and ensuring that its actions are relevant to the specific regional context. The Regional Platform 2 is a platform that coordinates the planning and implementation of activities, mobilizing the required financial resources, and facilitating communication and collaboration among members. It is also responsible for monitoring, evaluating and reporting on the activities undertaken by members. Additionally, the platform provides feedback on organizations from the region applying for ILC membership. To Ensure equitable land distribution and public investment that supports small-scale farming systems, including through redistributive agrarian reforms that counter excessive land concentration, provide for secure and equitable use and control of land, and allocate appropriate land to landless rural producers and urban residents, whilst supporting smallholders as investors and producers, such as through cooperative and partnership business models. EAFF therefore with funding support from the International land coalition is seeking the services of a consultant to undertake a comprehensive study on Family Farming Policies in support or against in line with FAO voluntary guidelines.

Family farmers are key in sustainably transforming agri-food systems to nutritiously feed the world; however, they are among the most affected by poverty and vulnerability (FAO, 2020). More than 75 percent of the world's poorest live in rural areas and depend on agriculture for their livelihood, with family farmers – in particular small-scale food producers, women, youth, Indigenous Peoples and ethnic minorities - among those facing the highest levels of economic, financial, social and environmental risks (IFAD, 2019). Addressing this situation requires a coherent set of policy and investment portfolios that comprise a nexus of measures (FAO, IFAD, UNICEF, WFP and WHO, 2021). The guidelines integrates the role of legislation in anchoring broader policy efforts to support family farming – with implications for numerous sectors of great interest for the sustainable agri-food systems transformation, thereby advancing the objectives of the UNDFF and the related SDGs. These guidelines are anchored on four components: access to resources and opportunities; sustainability and traditions; nutrition and healthy diets; and resilience and socio-economic services. Each of the components has outcomes leading to better access, enhanced systems, better nutrition and resilience and service (market/finance/others) to access by Family Farmers. FAO guidelines are important for adoption by countries in support of the family farmers. In line with this, the study will unpack how the sample countries have adopted the guidelines and specifically deep dive on the level of adoption whether as policies or under their national action plans.

#### 4. Overall objectives

The task objective is to align the UNDFF policies in support of Family Farming (FF)

#### • Objectives of the assignment

The objective of the consultancy is to:

- Highlight how countries under RP2 adopts the FAO guidelines under the UNDFF
- Provide information on how family farming policies have been adopted and how they are implemented in the countries
- o Report on the case studies in relation to the guidelines within the RP2 member countries
- Look at how Family Farming data (youth, women) could contribute to policy decisions in relation to Family Farming

#### 5. Scope of work

• Main activities and expected results/Outputs per each activity

-Synthesize how government from specific model region/countries in East, West and South Africa are implementing the FAO voluntary guidelines in support of Family Farming; case studies to be presented aside from the two model regions (Kenya and Tanzania) in the report

-Highlight how government's from specific model region/countries in East, West and South Africa implement

the UN Decade of Family Farming and how it correlates to FAO guidelines

-Look into how of land distribution policies affect youth and women and correlate it to its effect on family farming

-Outline various policies that are promoting family farming in the regions and those that do not promote family farming

-Highlight the opportunities of supporting Family Farming on the context of a changing climatic environment that predisposes the family farmer.

-Provide recommendations on how to include the family farming agenda within the government national action plans as a way to ensure food and nutrition security in Kenya and Tanzania and the other RP2 countries

#### • Approach and methodology of the assignment

The assignment is to be conducted as a desk study with the consultant gathering information in relation to the countries, through engagement of stakeholders including government agencies, non-state and other actors on land.

The consultant is expected to undertake the assignment in 2 months.
